# Raila moves to stem fallout as Ababu accused of abdicating role

ODM leader unhappy that secretary general and western colleagues raised concerns in the media instead of party structures

ODM leader Raila Odinga yesterday pressed party secretary general Ababu Namwamba on concerns he had abdicated his duties.

During the first party meeting since a rebellion was sparked in the party by six western MPs, Raila is said to have been unhappy with the leaders for raising party-related complaints in public.

Multiple sources that attended the meeting of the Central Management Committee said Raila put his party's secretary general to task for absconding his duties at Orange House.

Raila is also said to have taken issue with some senior party officials for frustrating Namwamba.

Last week, Namwamba and ODM vice chairman Paul Otuoma led a group of five MPs from the region in castigating the party leader and chairman John Mbadi for undermining them by visiting their constituencies without informing them.

The MPs also said the party had frustrated initiatives by Namwamba to rejuvenate the party and warned they would be forced to consider other options if the party did not pay attention to their grievances.

And in a five-hour meeting at Orange House meant to heal the rift, the committee gave disgruntled members two weeks within which to present their grievances for redress.

The committee chaired by Raila and in charge of the day-to-day management of the party affairs yesterday agreed that there were underlying issues raised by its secretary general and the five Western MPs.

According to a source, some members criticised the manner in which the team went to argue their case in the media and not through the laiddown party structures.

The officials were of the opinion that Namwamba and the disgruntled MPs should have channeled their grievances through the established party structures.

Raila is said to have told Nam-wamba that he had his blessings and should play his role as the secretary general and to avoid any unnecessary wrangles that could undermine

the party.
"This is not the time for quarreling, the elections are around the corner. That is not the way to go," Raila

Namwamba is said to have defended himself, protesting that the concerns raised by western MPs had been narrowed down to him with some party members directly attack-

He is said to have stood his ground and defended his position that there was no way he would have presented the matter to those being accused of frustrating his work plan.

The source added that Namwamba in particular raised concern over the claim by Siaya Senator James Orengo, during a meeting in Busia, that he (Namwamba) could have been auctioned to their rivals.

He also denied deserting his duties as the secretary general of the Orange

And at the press briefing, Nam-wamba who read the statement on behalf of the party, said the meeting was looking into the composition of Parliamentary Select Committees.

He however stated that they will meet in two weeks to iron out any emerging issues in the party.

Today we were meeting to look into the internal issues of the party. The issues are in the public domain and without pre-empting, it is sufficient to say we have put in place a framework to handle the emerging issues," said Namwamba.

"When issues are raised to strengthen the party, then that is not being disgruntled. We want the party strengthened," he maintained.

Mbadi noted the party constitution had given enormous powers to the office of the secretary general and that of the chairman and that nobody can purport to frustrate bear-

"The constitution has given im-mense powers to the SG and the chairman to an extent that they cannot be frustrated. Instead, the office bearers, if they decided, can frustrate others. But the SG and I have the re-sponsibility of serving," said Mbadi. The closed-door meeting that last-ed three hours was attended by three

party officials and vice chairmen Jo-sephat Nanok, Otuoma and John Waluke, an NEC member.

Others were National Treasurer Timothy Bosire, Women Leader Beth Syeng'o, Youth Leader John Ketora and National Assembly Deputy Minority Leader Jakoyo Midiwo.

### **Parliament** investigating Sh500 million SGR payouts

Parliament is investigating claims Sh500 million may have been paid out irregularly as compensation for land acquired to build the Standard Gauge Railway (SGR).

Lands committees of the Nation-

al Assembly and Senate are investi-gating alleged fictitious payments by the National Land Commission (NLC) and the Kenya Railways Corporation

This follows complaints by people

who claim compensation was skewed even after their properties were taken. Also, a KRC audit has raised con-cerns over alleged questionable pay-outs and blames NLC for the irregu-

The report unearths how payments were made to unknown people and compensation inflated in

Even worse, there are those whose names are not in NLC's master list or KRC payment schedule yet their prop-

In its report, KRC is concerned with the double payments of Sh1.09million and Sh3.5million said to have been paid to two wrong people. It is also concerned over what it terms irregular payment at Manyani and Mbololo. At least Sh11.3million was paid without identifications and names as well as payment of Sh9.8 million, among others are troubling KRC.

#### IRREGULAR COMPENSATION

Valuation of a sisal plantation, resulting in a variance of Sh337.2 million and alleged irregular compensa-tion of public land of Sh43 million are some of the issued to be investigated.

NLC chief executive officer Tom Chavangi told The Standard he could not comment on the report.
"That report you are referring to

is a draft and I cannot comment on it until when it's finalised," he stated.

George Oner, a member of the National Assembly lands commit-tee, said although KRC's report is just a draft, it forms a basis for investigations to establish whether the compensation process is above board.

'We are inviting the two agencies to appear before us on a yet to be agreed upon date to shed light on this matter. There are complaints that must be substantiated," said Oner.

He added: "The committee has seen the report and we will use it to frame questions to both KRC and NLC. There is the issue of huge disparity in the compensation of sisal farms at the Coast and the equal payment of all lands in Voi despite the size."

The SGR compensation issue has

been outstanding for a while and the two agencies have shifting blame, with NLC claiming it is KRC that is mandated to make the payment.

In its report, KRC questions pay-ments allegedly made to the wrong people, yet NLC has details of the deserving beneficiaries.

It is the compensation trail that undeserving Kenyans were report-edly paid Sh3.5 million, 14 unknown people got Sh 5.1million and 16 others with only one name pocketing Sh11million. Also, there was an alleged over-payment of Sh1.09 million, the report further says.

## Muturi tells CORD to name Justice committee members by today

On June 16, the Speaker announced the discharge of 11 CORD members who sat on the Justice comdling of the Independent Electoral and Boundaries Commission issues when the coalition was pushing for the process to be tackled by other or-

The CORD members discharged from the committee were David Ochieng, Agostinho Neto, Peter Kalume, Fatuma Ibrahim Ali, Ben Momanyi, Tom Kajwang, Mutua Mutemi, Olago Aluoch, Christine Ombaka, Benjamin Andai and Mwamkale Ka-
